The filling of examination form under special provision is permitted subject to following conditions.

1. The penalty for each examination form is Rs.5000/-
2. The candidate has to submit an undertaking as per Annexure-I
3. Institute shall check availability of question paper code for which the candidate is appearing for exam in summer-2019 Time table.
4. The institute has to submit an undertaking in the form of self-declaration on the institute letter head along with the list of students who has filled the examination form in special provision.
5. Hall ticket and separate non-theory e-mark sheets will be made available in institute login on 28/03/2019.
6. Institute can conduct the non-theory term end exam for these candidates even before the availability of e-mark sheets. Mark sheet shall be filled & confirmed once made available in the login.
